Sidestepping the Constitution: How Julie Daniels and Oklahoma Lawmakers Game the System

The Oklahoma Constitution was expertly crafted to deter the Legislature from creating "special laws" such as extracting money from taxpayers and distributing it directly to particular individuals or companies.

The Constitution's architects were obviously thoughtful and aware that such actions would likely trigger widespread corruption

If special laws were allowed, corrupt actors would cultivate relationships with politicians, financing their election campaigns, and subsequently harvesting financial benefits once those politicians ascended to power and passed the special laws.

A profound quote from 1904, shortly before the approval of Oklahoma's Constitution declared that: "No man who depends on special laws for his prosperity was ever a patriot."

Over the years, legislators have strayed from this wisdom and abandoned the values of the state's earlier days. They have become exceedingly adept at very creatively crafting these special laws in an attempt to sidestep the prohibition

Case in point: Julie Daniels and the Legislature just voted to award millions of dollars in benefits to the Oklahoma City Thunder.

These benefits are designed to last for the next fifteen years.

The Constitution bars the Legislature from concocting a special law that explicitly states, "we are going to give millions to the Oklahoma City Thunder."

So, how did they navigate this obstacle? They re-authorized a law that essentially proclaims "Organizations that align with North American Industry Classification System code 711211, and maintain an annual payroll of at least \$2.5 million, qualify for millions of dollars in benefits courtesy of the taxpayers."

This highly targeted language effectively rules out the majority, if not all, Oklahoma businesses, apart from the National Basketball Association.

The fact that the Legislature would construct what is essentially a special law to favor millionaires is distasteful.

Moreover, compelling taxpayers to subsidize millions for this pro-CCP, anti-American organization is particularly egregious.

Knowledgeable policymakers have very low confidence in the ability of election officials to truly cure the voter rolls of those who may use the illegal alien driver's license number in their registration. The bill specifically prohibits the state election board from retaining possible information about violations of the voter registration law. This will make it difficult for the public to audit the election board to determine how many new abuses are taking place as a result of the new illegal alien driver's license.

Impact to the Legal Citizens:

It's unclear what the full financial impact on legal citizens might be if illegal aliens are granted official Oklahoma government identification. Policymakers estimate that up to 33,000 illegal aliens could potentially exploit this proposal.

In 2017, Oklahoma officials, including Julie Daniels, opted to comply with the federal government's controversial 'Real ID' data collection mandate. This decision appears to have hampered the state's capacity to efficiently provide driver's license services to its current residents. News reports now often focus on the long lines of Oklahomans struggling to receive these license-related services and its unclear if they will ever get a handle on what is going on. Adding thousands of illegal aliens to this equation is likely to further deteriorate the already subpar service.

Stearman also expresses concern that this form of identification could be misused to access a variety of taxpayer-funded services. She emphasizes that government spending is already spiraling out of control, highlighted by a more than 30% increase in state appropriations—endorsed by Julie Daniels—in just the last year.

Furthermore, issuing state IDs to those violating the law poses many unknown societal risks. One clear area of concern is banking. The growing power of cartels could potentially exploit Oklahoma's banking system to launder money. With the Democrats' current border policy, these cartels are already seizing control of the border areas, posing an increasing threat to the safety and well-being of Oklahomans.

Additionally, if word spreads that Oklahoma is providing official government identification to illegal aliens—an action minority of other, mostly left-leaning states have taken—it creates a new incentive: 'A prosperous, low-tax red state is offering state-issued IDs to illegal aliens; let's go there.'

Then, there are the nationwide implications of this proposal. If Julie Daniels can persuade Oklahoma, one of the most staunchly Republican states, to endorse this measure, it will serve as justification for other states to follow suit. Advocates will likely argue: "Look, Oklahoma did it, and they're among the reddest states in the country, so you can too."

Stearman argues that Oklahoma's status as a red state makes it a prime target for sweeping leftist agendas. She says, 'Those pushing George Soros-style policies know that influencing Republican legislators in Oklahoma can set a precedent for other red states to emulate. That's why it's crucial to elect officials who won't be swayed by special interest money.'"

Daniels Should Have Known Better

The illegal alien driver's license bill was sponsored by one of the Legislature's most liberal members, Oklahoma City Immigration Attorney Michael Brooks. Brooks' law firm solicits those who "do not have papers" to contact his firm for the purposes of potentially suing Oklahoma citizens for "personal injury" matters.

Stearman believes this should have been Daniels's first clue that this bill wasn't something that would be acceptable to the voters of our area. "It's hard to make the case that Daniels was just innocently 'confused' by this bill.

Whenever a liberal immigration attorney asks to give illegal aliens official identity documents, any

reasonable legislator would have immediately hit their 'NO!' button."

The Real Reason:

Stearman suggests that Daniels wasn't simply making a mistake but was actively voting against our local values and betraying the voters to whom she campaigns as a "conservative."

Daniels has a record of taking money from and voting with lobbyist-represented groups. Stearman has observed this first-hand and notes that these groups have bought and control many Oklahoma legislators.

"As a rule of thumb, whenever the inexplicable happens in the Legislature, you simply need to follow the actions of the lobbyist groups. And, in this case, that trail leads directly to Julie Daniels and her inexplicable 'yes!' vote in favor of giving official driver's licenses to illegal aliens."

By contrast, Stearman will not accept money from lobbyists, nor the corporations that hire the lobbyists and funnel thousands of dollars into politicians' campaigns.

The Nationwide Implications of Our Vote on June 18th

While the bill did pass the Senate, it wasn't approved by the House; however, there are some very determined organizations that support this proposal and are likely to bring it back again.

Stearman believes the Senate District 29 vote in June will be the referendum on this issue.

If the voters of Senate District 29 overwhelmingly defeat Daniels based on this issue, we will send a powerful message to the entire legislature:

"Giving criminal illegal aliens a foothold in Oklahoma is a sure way to lose your next election."

This will likely spell the end for the driver's license for illegal aliens proposal in Oklahoma, and maybe even in the other red states that are sure to copy Oklahoma if the measure passes here.

Thus, on June 18th, the voters of Senate District 29, could be the deciding factor in this issue.

worse, some politicians amass such significant war chests that they discourage potential challengers from running, thus depriving constituents of electoral choices.

Based on her observations, Stearman believes this flow of money explains why some politicians campaign as conservatives but inexplicably betray these values once elected. She wants no part of this "legalized corruption." elected on June 18, Stearman will reject all gifts and contributions from lobbyists and their employers.

Stearman suspects this influence accounts for many of the bizarre votes cast by Julie Daniels. For instance, Daniels has frequently accepted such gifts and contributions, including a recent \$160 dinner at an Oklahoma City steakhouse.

Why Wendi Stearman Voted 'No' to Government-Controlled **Medical Data**

ur health privacy rights will be on the ballot on June 18.

In 2010, a constitutional amendment was approved by 64% of Oklahoma voters.

The amendment was in response to the federal government's Affordable Care Act, commonly known as "Obamacare."

Central to this socialistic healthcare proposal was the ability of government to centralize medical data.

Oklahomans wisely recognized this when they voted to create the new constitutional protections. And, they took action.

Their new constitutional provision prohibited the legislature from making any law that would force a person to participate in a healthcare system that mandates the sharing of medical data.

Despite this, Julie Daniels and the Republican-led legislature appear to have tried to bypass this constitutional provision.

Senate Bill 574 and Senate Bill 1369 have set the stage for compelling numerous healthcare providers to contribute medical records to a government-managed, centralized repository.

This repository will store extremely sensitive, personally identifiable healthcare information.

This includes mental health records, current prescriptions, drug allergies, diagnoses, lab results, hospital discharge documents, and perhaps most alarmingly, vaccination records.

Earlier this year, acting under the authority of these new laws, the Oklahoma Healthcare Authority attempted to mandate that healthcare

providers participate in the system.

Fortunately, Governor Kevin Stitt vetoed this mandate, after much public outcry.

However, these problematic laws are still on the books, and it's likely that the healthcare bureaucracy will try again sooner rather than later. Once Stitt leaves office, there's likely going to be few left in state government to stop them.

Wendi Stearman was one of just 10 representatives with the extreme foresight to vote against SB 1369 and one of four to vote against SB 574. Julie Daniels voted for both.

Stearman understands the many potential abuses once sensitive information is under centralized government con-

From hacking implications to the possibility of blackmail, every abuse is on the table as the government has proven to be a notoriously poor steward of electronic records. The array of potential abuses is unimaginable.
